We have received information indicating that tripping of the lock-out overheat switch has been occurring in the above designated heater. Under reduced airflow conditions it is possible to develop sufficient heat to trip the lock-out overheat switch even though the heater does not have a serious malfunction.

To eliminate this condition, several changes have been made and are available for the above designated serial number aircraft in the following kits:

PA-23-250 (six place) Aztec B	Fuel Injection Model only requires a wiring modification contained in Kit Number 756 816
PA-23-250 (six place) Aztec C	Requires a cycling switch, overheat switch and wiring change contained in Kit Number 756 817
PA-30 Twin Comanche	Requires a new fuel control valve and re- wiring modification contained in Kit Number 756 815
