INSTRUCTIONS FOR REWIRING TURBOCHARGER LOW OIL PRESSURE WARNING LIGHTS PA-30 TURBOCHARGED

- a. Ascertain that master switch is OFF.
- b. Remove the access cover to the circuit breaker panel.
- c. Remove the screws that secure the circuit breaker panel in the floor opening. Two screws are located at each side of the panel.
- d. Pull the breaker panel up from the floor opening far enough to gain access to its under side.
- e. Disconnect the turbocharger low oil pressure warning light wire from the stall warning circuit breaker and reconnect it to the adjacent flap solenoid circuit breaker. The circuit breakers are identified by their identification placard on the face of the panel. There is no identification code on the turbocharger light wire, though the other wire on that circuit does have a code number.
- f. Reinstall the breaker panel in the floor opening and secure with screws.
- g. Remove the placard labeled "T/C CTL" from the face of the panel and replace it just aft of the flap solenoid circuit breaker. Do not cover the placard IND.

Time of Compliance: At next routine inspection or within next 100

hours operation.

It has come to the attention of the manufacturer the turbocharger oil warning light power wire is not installed in the most desirable location.

The turbocharger oil warning light wire is presently connected to the Stall Warning Circuit Breaker. This wire and the corresponding placard is to be moved to the Flap Solenoid Circuit Breaker. Enter this action in the Aircraft Log on date accomplished.
